Median rent is an indicator of affordability. If rent is increasing greatly, that can be an indicator of lack of affordability. In district 51A, rent increased 11% between 2013 and 2018. The district saw the 24th highest rent increase out of 134 districts.

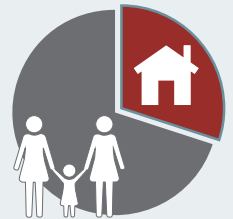
Median renter income is an indicator of what people can afford for rent. If incomes stay flat or decline, it can be an indication that cost burden is increasing. In District 51A, renter income increased 1% between 2013 and 2018. The district ranked 109th of 134 in terms of renter income increase.

INCOME NEEDED TO AFFORD RENT:
\$44,360

The income needed to afford rent -- \$44,360 -- is less than the median renter income in the district.
With a gap of \$-2,751, rent in District 51A is affordable.

COST BURDENED RENTERS | **2,952**
PERCENT COST BURDENED | **41%**

Cost-burdened renters pay 30% or more of their income on rent and an estimated 2,952 District 51A residents may have to sacrifice education, food, and medicine to afford a place to live. For highest cost burden, the district ranked 79th.

SENIOR COST BURDEN | **77%**

District 51A ranked 6th out of 134 for the percentage of seniors struggling to afford housing.

SEVERE COST BURDEN | **19%**

Severe cost burden means a family is paying 50% or more of their income on housing. District 51A was the 82nd highest of 134.

People of color and indigenous people are more likely to be renters and less likely to own their own home. They are also much more likely to experience cost burden.

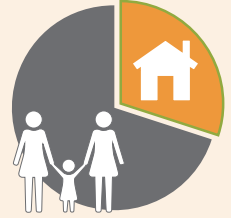

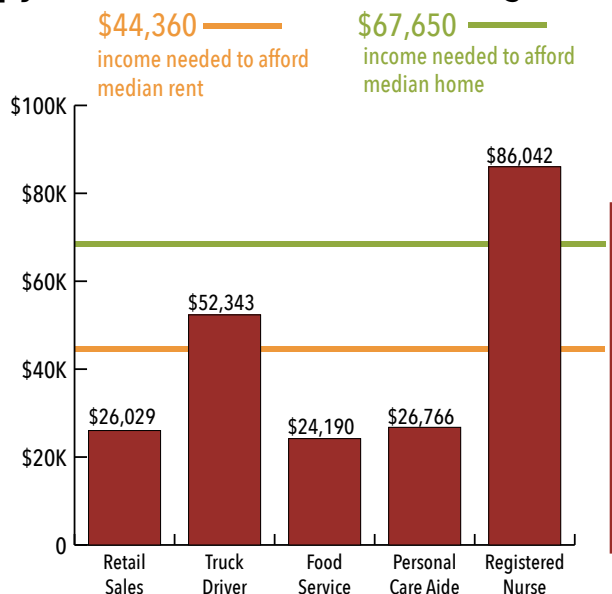
